1	One national visa application form duly completed in French or English, not stapled, with a colour passport photo not older than 6 months, 35mm x 45mm, on a white background. 用英语或法语填写的长期签证申请表，单面打印，无须装订，附 1 张 2 寸白底彩色护照照片（近 6 个月内拍摄）。			
2	Passport valid for at least 3 months after the expiration date of the visa requested (+1 copy of the first page of passport and of previously issued Schengen visas). The passport should contain at least 2 empty pages when applying for the visa and should have been issued within the previous 10 years. 护照原件，首页及申根签证页复印件，护照有效期至少为本次签证到期后 3 个月仍有效。护照至少有两张空白签证页，并且护照签发时间不超过 10 年。			
3	Overseas medical travel insurance valid for all Schengen countries for a minimum duration of 3 months and a minimum coverage of 30.000 EUR for all risks like accident, urgent medical attention, emergency hospital treatment and repatriation. This insurance is not required if the applicant can prove that before the arrival in Luxembourg, he/she is covered by an insurance through the future employer/spouse/family (e.g. certificate from "Caisse Nationale de Santé"). 旅行保险，涵盖在申根区整个旅行期间至少 3 个月的所有医疗费用，包含回国治疗、紧急医疗救助、住院等，最低保额为 3 万欧元；或在抵卢前已通过未来雇主、配偶或家庭购买了保险（如卢森堡国家医疗保险）的证明。			
4	Copy of "Temporary Authorization to Stay" issued by the Luxembourg Directorate of Immigration. 临时居留许可复印件。

6	Parental authorization for minors traveling alone or with one parent + 1 copy: <ul style="list-style-type: none"> <li>If minor is travelling alone: notary certificate of permission to travel from both parents or legal guardians, apostilled by Chinese MFA.</li> <li>If minor is travelling with one parent: notary certificate of permission to travel from the parent/legal guardian not travelling, apostilled by Chinese MFA.</li> <li>If parents are not living in China: notary certificate of permission to travel legalized/apostilled by the relevant authorities in the country of residence.</li> </ul>
